### Assistant Chief Operations Officer, Asset Recovery Unit

MTA New York City Transit (NYC Transit) is seeking an **Assistant Chief Operations Officer (ACOO), Asset Recovery**, to oversee all disposal functions for NYC Transit, including, but not limited to, agency-wide solid waste Disposal, Recycling of excess and obsolete non-hazardous material and equipment, and Sale of surplus materials and NYCT memorabilia items. The ACOO will also be responsible for managing NYCT's current and future Recycling programs, and will direct daily operations through Project Managers who supervise the agency's waste removal activities by various contractors servicing over 150 NYCT locations in the 5 boroughs of New York City, plus 468 NYCT subway stations throughout New York City. Additionally, the ACOO will manage NYCT's agency-wide Scrap commodity sales, removal and recycling program, execute NYCT's internet Sales program, and determine best practices for disposing NYCT's excess, obsolete, and unwanted material. The ACOO will revamp NYCT's recycling policy, manage the rejected material program, and direct operations for the timely, cost effective resolution of rejected shipments.

As the largest public transportation agency in North America, and one of the largest in the world, NYC Transit moves 8 Million people daily, throughout the five boroughs of New York City, with 24/7 service, 365 days a year.
