**ORDER APPROVING CHAPTER 11 TRUSTEE'S
ABANDONMENT OF CERTAIN PROPERTY OF THE ESTATE**

THIS CASE came on for hearing on November 13, 2014 ("Hearing"), on the Chapter 11 Trustee's Notice of Intention to Abandon Property of the Estate (Doc. 203) (the "Abandonment"). The Court having considered the Abandonment Motion, the record in this case, and having heard from the parties in attendance at the Hearing, finds that proper notice was given and finds cause to approve the Abandonment pursuant to Section 554 of the Bankruptcy Code and for the reasons stated and recorded in open Court at the Hearing. Accordingly, it is –

ORDERED that:

1. The Abandonment is approved. All objections are hereby overruled.
2. The Trustee is immediately authorized to abandon all collateral of Regions Bank, more particularly described in its Motion for Relief from Stay (Doc. 159) -- including used
